Purpose of the processing and legal basis for the processing

Exercising your rights as a data subject

You have the following rights against König Komfort- und Rennsitze GmbH under the applicable data protection law with regard to your personal data:

- Right to information: You can request information from König Komfort- und Rennsitze GmbH at any time as to whether and which personal data about you has been stored. The provision of information is free of charge for you.
- Right of rectification: If your personal data stored by König Komfort- und Rennsitze GmbH is incorrect or incomplete, you have the right to demand the correction of this data at any time.

- **Right of erasure:** You have the right to request the deletion of your personal data if and insofar as the data are no longer needed for the purposes for which they were collected or if the processing is based on your consent and you have withdrawn your consent. In this case, König Komfort- und Rennsitze GmbH must stop processing your personal data and remove it from its IT systems. A right to deletion does not exist insofar as the data may not be deleted due to a legal obligation or must be processed due to a legal obligation; the data processing is necessary to assert, exercise or defend legal claims.
- **Right to limit processing:** You have the right to request that the processing of your personal data be limited.
- **Right to data portability:** You have the right to receive the data you have provided in a structured, common, and machine-readable format as well as the right to have this data transferred to another person responsible.
- **Right to object to processing:** You can object to the processing of your data by König Komfort- und Rennsitze GmbH at any time.

Right of appeal to a data protection supervisory authority

In accordance with Art. 77 GDPR, you have the right to lodge a complaint with a data protection supervisory authority if you believe that the processing of your personal data violates data protection law.

Duration of data storage

Insofar as your personal data is subject to statutory storage obligations or is part of documents that are subject to statutory storage obligations, König Komfort- und Rennsitze GmbH will store this data for the duration of the statutory storage period. The retention periods to which König Komfort- und Rennsitze GmbH is subject vary in length and usually concern a period of 6 to 15 years.
